3. I take liability for any loss or damage caused both negligently and maliciously, exclusively or in competition with both the organizers, the venue and any other individuals or legal entities participating in the Event.

I declare that I agree that the filmed sequences and/ or the images photographed with the minor or the undersigned are free of copyright and I agree to assign all rights in the edited or unedited materials to the organizer of the Event Asociația Club Sportiv Polo Singureni/its partners. In this capacity, the Organizer/its partners are also entitled to retransmit them, without any prior consent, to communicate them publicly, to display them in any way they deem appropriate, including but not limited to being posted on the official page of the Event, Facebook, Instagram etc., as well as of the project partners, for the purpose of advertising/ promoting the Event. This Agreement is valid provided that the rights and freedoms of the minor, his/her dignity and the right to his/her own image are respected.
